

## CONTRACT FOR SERVICES/TRAINING

1. Services and/training requested by Owner and to be provided by ABK:

2. Terms of Payment for Services/Training:

- A. Owner shall make a non-refundable deposit of \$ \_\_\_\_\_ to reserve services/training time.
- B. When Owner's dog is dropped off at ABK for services/training an additional sum of \$ \_\_\_\_\_ representing payment for services for a period of \_\_\_\_\_ days/weeks, shall be deposited. Owner and ABK agree that the amount estimated for services may need to be modified based on the dog's progress in the training sessions and/or based upon services actually provided. Owner agrees to pay for additional services/training, if they are necessary, at the rate of \$ \_\_\_\_\_ per day/week.
- C. Owner agrees that all fees and charges are to be paid with 7 days of billing and that final payment is due upon completion of training. Owner understands and agrees that ABK shall have a possessory lien on Owner's dog which lien shall remain in effect until Owner's account with ABK is paid in full. The possessory lien hereby granted to ABK includes the right of sale of Owner's dog if ABK must do so to recover the fees owed under this agreement.
- D. In the event that ABK must communicate with Owner for reasons arising out of this agreement, Owner's communication information is as follows:

3. **Owner Responsibility for Dog's Health:**  
Owner is responsible for having the following vaccination shots current on the dog(s): 1. rabies/distemper (including leptospirosis), and 2) kennel cough(Bordetella) (within the past 6 months).  
Evidence of vaccinations provided by a licensed doctor of veterinary medicine is required on or before the day a dog arrives for services/training.
4. **Venue for Dispute Resolution:**  
In the event of a dispute arising out of any of the terms or conditions of this agreement, the parties agree that such dispute shall be venued in Kanabec County, State of Minnesota, United States of America.
5. **Additional Terms:**
  - A. **HOLD HARMLESS:** The Client will hold Autumn Breeze Kennel harmless and indemnify ABK from any and all claims, liability, damage, loss or expenses arising out of any injury to any persons or to any person's property by Owner's dog(s) while said dog is in the care, custody and control of ABK.
  - B. Owner acknowledges that dog training will not provide exact results. Each dog is different in regards to ability, intelligence and temperament. ABK makes no expressed or implied guarantee as to the results reached in training or regarding the level of competency that will be reached by Owner's dog(s).
  - C. ABK reserves the right to terminate this agreement at any time, and to request that Owner pick up their dog(s). All pre-paid training fees will be refunded on a pro-rated basis in the event ABK makes such request.
  - D. ABK shall not be responsible for the cost of replacing Owner's dog(s) or for any damage of any kind, should Owner's dog(s) die, be stolen, escape, or become injured, or ill while in the care of ABK. Proper care will be given and generally accepted training methods will be followed while dog(s) is (are) in ABK's care.
  - E. Owner and ABK agree that this written agreement sets forth the entire agreement of the parties – there are no oral or other unwritten terms of the agreement.
  - F. At the conclusion of the agreement and at such time as Owner picks up Owner's dog, Owner will receive a demonstration of dog's ability and a written list of instructions to continue enforcing skills learned in the training. In the event that Owner has any questions or concerns about the skills taught to Owner's dog Owner must present said questions or concerns to ABK within 30-days of the conclusion of training in order for ABK to adequately and properly answer the question or provide necessary correction.
